Environmental and Social Report: It is Important!

- Environmental and Social Questionnaire is mandatory.
- You are required to provide responses to all of the questions.
- The questionnaire is intended support Signet and our suppliers in creating positive environmental and climate impacts across the supply chain.
- Full Suite of Reports SRSP, Due Diligence and E&S are all Due October 31, 2024.



Signet's Sustainability Program

- Signet is subject to US regulations related to greenhouse gas reporting and product claims
- Signet's publicly available Corporate Sustainability goals include specific decarbonization targets. And this year, Signet will continue to collect and analyze our Scope 3 data. Scope 3 data includes "Purchased goods and services," which also is our suppliers' Scope 1 and 2 data.
- Signet's Corporate Sustainability Goal reads: "By Fiscal 2025 yearend, initiate energy and CO₂ emissions reduction action plans following climate risk and opportunity analyses for Scope 1, 2, and 3 CO₂ emissions."

- The SRSP report and the E&S report may be completed by different team members at your company. Please note the products supplied to Signet should be the same in the SRSP report and the E&S Report.

- We will ask you for the name and contact information of the person completing the E&S report.
- We will contact you if we have follow-up questions on your answers.

Supplier Background

- Primary business activities (i.e., Design and Manufacturing, Cutting and Polishing, etc.)
- Carbon neutral and net zero facilities and products.

Environmental Impacts and Risks

- Sustainable packaging efforts.
- Environmental impact reductions of materials or operations.
- Water reduction programs and risk assessments.


Energy Use and Greenhouse Gas emissions

- Energy use at facility or site.
- Greenhouse gas reporting and reductions.
- Environmental targets, standards, and certifications.
